This letter is in reference to the summary budget dated July 14, 2017 that was submitted by the Michigan Humanities Council for NEH grant SO-253129-17.

This budget for the funding period November 1, 2016 through October 31, 2017 is approved. With the exception of the funds that are budgeted for regrants, the Michigan Humanities Council has the authority to make whatever budget changes it deems necessary to carry out its program activities. Regrants are defined as support for humanities projects selected in open competition on the basis of established criteria that are widely known.

The allocation of federal funds for regrants currently stands at a total of \$237,700. This amount includes \$237,700 in outright funds and \$0 in federal matching funds.

The cost-sharing requirement for this grant was stated as condition 7 of the grant amendment dated May 19, 2017.

All other terms and conditions of this grant remain in effect.
