

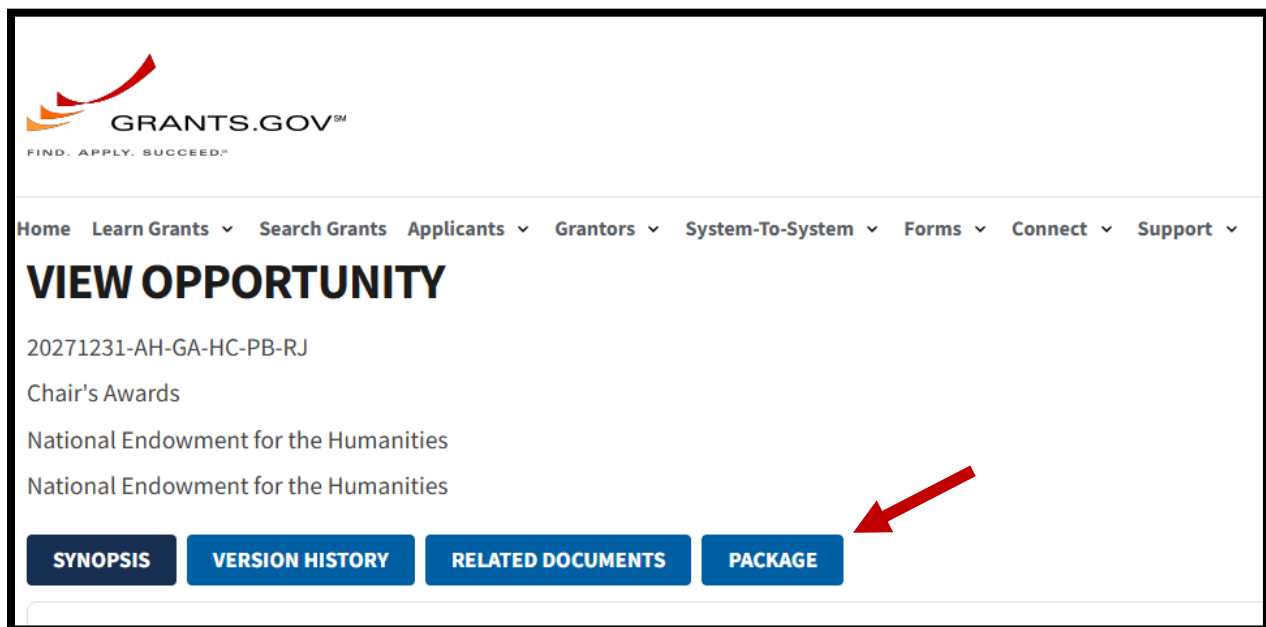
# *Celebrate America!*

## How to Apply: Step-by-Step Guide

Grants for *Celebrate America!* will be reviewed on a rolling basis and offered as Chairman's Awards. Please refer to the images below to assist you in navigating to the correct application package in Grants.gov.

Log in to your Grants.gov account and follow this link to the opportunity:  
<https://grants.gov/search-results-detail/357263>. Note that you must use the direct link; you will not be able to find the package through a traditional search of open opportunities.

Select the "package" button.



Find the second opportunity listed, "**Chairman's Awards: Celebrate America!**" and click "Apply."

For the **Supplementary Cover Sheet for NEH Grant Programs [V3.0]**, you will be asked to provide information about your project funding in section three. Note that this program ONLY provides Federal Matching funds; therefore, put \$0.00 in the Outright Funds box.

Likewise, when you fill out the **Research & Related Budget 10YR [V3.0]**, note that your budget must total the federal matching funds requested from NEH **plus** the required third-party, nonfederal gifts. See the [NEH Federal Matching Funds Guidelines](#) regarding the allowability of gifts for matching purposes.

In the example provided above, the total budget would be \$50,000. This will include direct and indirect costs. You will need to disregard the information in the Notice of Funding Opportunity on the top of page 17. Total project costs should not exceed \$50,000.
