## NATIONAL ENDOWMENT FOR THE HUMANITIES SERVICE CONTRACT INVENTORY PLANNED ANALYSIS FOR FISCAL YEAR 2021

- **1. Background**. Public Law 111-117, Consolidated Appropriations Act, 2010 requires civilian agencies to prepare an annual inventory of their service contracts and to analyze the inventory to determine if the mix of Federal employees and contractors is effective or if rebalancing is required. The National Endowment for the Humanities (NEH) is required to develop an inventory of the Agency's service contracts as it is subject to Section 743 of Division C of the Act.
- 2. Planned Analysis. NEH will conduct analysis on all contract actions with a Product or Service Code (PSC) identified in the Office of Management and Budget (OMB), Office of Federal Procurement Policy (OFPP) Memorandum dated November 5, 2010, Subject: "Service Contract Inventories." NEH will use the data elements cited in Section 743 of Division C of the Consolidated Appropriations Act, 2010 and followed the guidance outlined in OMB-OFPP's Letter 11-01 "Performance of Inherently Governmental and Critical Functions" in its analysis.

The total population size for the FY 2021 Service Contract Inventory is not yet determined. As of August 25, 2021, NEH has awarded 21 actions with a total obligated just under \$1.6M; the below table is a consolidated list of all PSCs for contract actions awarded to-date. It is highly likely that these will be the PSCs reviewed and analyzed for NEH's FY 2021 Service Contract Inventory Analysis. These PSCs account for 87% of the total funds obligated to-date, and 68% of the actions awarded to-date.
