## Baseline Certification Assessment

*This document provides an example of a reporting template for agencies in response to the baseline certification assessment requirement in the Federal Cybersecurity Workforce Assessment Act of 2015.<sup>i</sup> Agencies are NOT required to use this reporting template and are ultimately responsible for responding to Congress. Agencies may refer to the MAX collaboration site<sup>ii</sup> for examples of agency methods for collecting certification data.*

### Federal Cybersecurity Workforce Assessment Act of 2015 Section 303

**BASELINE ASSESSMENT OF EXISTING CYBERSECURITY WORKFORCE.**—Not later than 3 months after the date on which the procedures are developed under subparagraphs (B) and (C), respectively, the head of each Federal agency shall submit to the appropriate congressional committees of jurisdiction a report that identifies—

- I. the percentage of personnel with information technology, cybersecurity, or other cyber-related job functions who currently hold the appropriate industry-recognized certifications as identified under the National Initiative for Cybersecurity Education;<sup>iii</sup>
